New Business:

The board reviewed the current Cost vs. Expense estimate of processing commercial recycling through the transfer station. The need for additional lighting for the trailer parking area was discussed. Jeff Swisher moved that a solar powered security light be purchased and installed. Total cost to be less than \$300 and treated as a regular expense. The motion was seconded by Galen Capron and was approved with all voting aye.

Holiday bonuses for the landfill staff was discussed. Dave Dirks moved that a bonus in the amount of \$125 be given to all hourly landfill employees. Galen Capron seconded the motion and it carried with all voting aye.

Jeff Swisher moved to adjourn the meeting. Galen Capron seconded the motion and the motion passed with all voting Aye. The meeting adjourned at 7:05.
