Chairman Margo Ahrendsen called the meeting to order at 6:35pm.
Moved by Chris Lux seconded by Dennis Coon to approve the May 31, 2022 EMS Advisory Council Meeting. All aye. Motion carried.

Discussion started with Sheila Frink going over the brochure. Members had changes they wanted made, so we went column by column over the brochure.

Discussion on costs for t-shirts, banners, brochures, etc. Sheila Frink had a breakdown of costs in the handout. For yard signs, it was decided to go with Monticello Express with 200 depending on the shipping costs. That would be $\$ 1312.00$ just for the signs. Two $8^{\prime}$ banners from Monticello also so we would have one for each side of a vehicle. Stand up flags were discussed, but they are hard to read. For posters, EMA can print some here and see what Monticello Express would charge. Billboards seemed like a large investment for only one highway.

The Council discussed the upcoming events and what items were needed. Jeff Swisher asked about having the Fair put up "Vote Yes for EMS" on the jumbotrons. Katrina Rix will discuss that with Lucas Gobeli. Also discussed having a table by the front entrance of the Fair with information. Also discussed
using the EMA texting program for a one-time text closer to the vote. Brenda Leonard will discuss with her Commission. Cities can put on their local channels if they have them.

Cost for the t-shirts and marketing products was discussed. Jones Co EMS Association has pledged $\$ 5,000.00$ towards the promotion of the vote. May have another $\$ 1,000.00$ to add. Discussion held on other avenues of funding. Brenda Leonard was asked about the BOS adding to the funding if needed. Discussed it is an election held by them, but unsure if they have ever promoted an election before.

Motion by Katrina Rix second by Chris Lux to ask the Jones County Board of Supervisors to consider donating to the marketing fund if it is needed. All aye. Motion carried.

T-shirt orders need to be turned in ASAP, discussed offering them for sale as a fundraiser.
