Jones County Solid Waste Commission Meeting Minutes

November 1st, 2022

The Jones County Solid Waste Commission meeting was held at the Jones County Courthouse. Those present were Chairman Russ Benke, Ned Rohwedder (Jones County Board of Supervisors), Jeff Swisher (Jones County Board of Supervisors), Dave Goedken (Monticello), William Roller (Morley), Dave Dircks (Olin), Darrin Byers (Oxford Junction), and Karl Taylor (Director JCSWC).

The meeting was called to order at 5:00 p.m. by Chairman Benke.

A motion was made by Ned Rohwedder to approve the minutes from the previous month's meeting. Jeff Swisher seconded the motion and it passed with all voting Aye.

The expenditures and financial reports were reviewed with Jeff Swisher making a motion to approve them. Dave Goedken seconded and it passed with all voting aye.

Old Business:

The board revisited the issue of adjusting tipping fees to offset increases in operating costs. The issue was tabled at the October meeting in order to assemble current and detailed numbers on current financials. After reviewing potential losses moving forward in FY 2023 a motion was made by Ned Rohwedder and seconded by Dave Goedken to increase tipping fees for trash to \$65/ton effective January 1, 2023 unless ECICOG has clarification on the timing and amount of notice required. The motion passed with all voting Aye.

New Business:

A motion was made by Dave Goedken to list the Ford tractor owned by the commission up for sale on BigIron.com. Jeff Swisher seconded the motion and it was approved with all voting Aye.

A discussion of moving forward with the addition of a glass recycling container was tabled until the December meeting to allow ECICOG to provide details on the grant application process.

Jeff Swisher moved to adjourn the meeting and it was adjourned at 5:50 p.m.
