The Auditor met with the Board for various items as noted in the motions below and to discuss the inclement weather policy.

Moved by Oswald seconded by Schlarmann to approve the hiring of Luke Authier as a full time radio operator starting at \$19.19 per hour, effective December 19, 2022. All aye. Motion carried.

Moved by Rohwedder seconded by Schlarmann to approve the hiring of Diane Highes as a part time cook starting at \$17.00 per hour, effective December 13, 2022. All aye. Motion carried.

Moved by Swisher seconded by Schlarmann to approve a Class C Liquor License, with Outdoor Service and Sunday Sales privileges, for Jones County Local LLC, doing business as Jones County Local LLC, 22962 County Rd.
