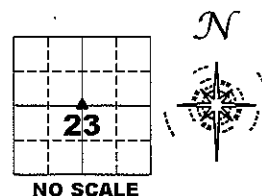

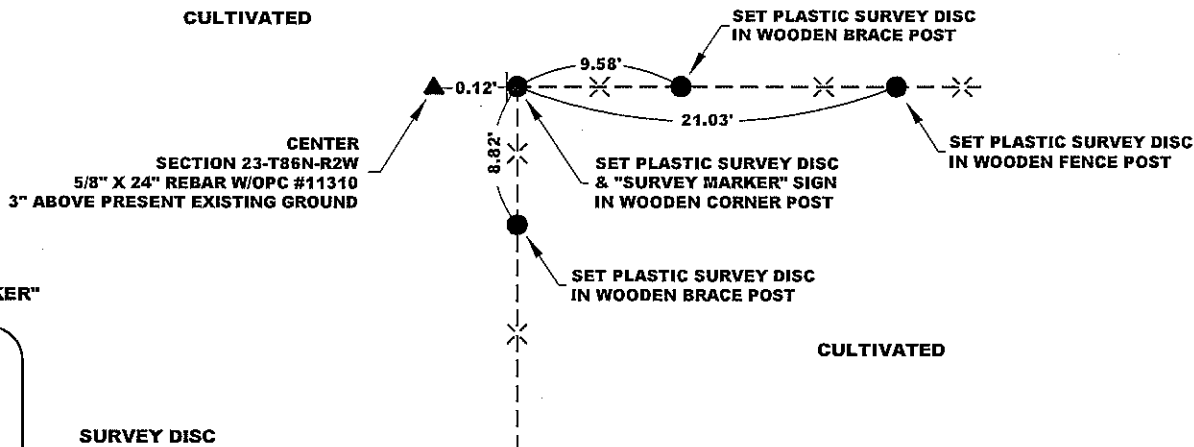

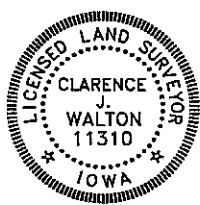

MONUMENT DESCRIPTION AND HOW ESTABLISHED SET 5/8" X 24" REBAR WITH ORANGE PLASTIC CAP # 11310 3" ABOVE PRESENT EXISTING GROUND SURFACE NEXT TO CORNER POST OF FENCE FROM SOUTH AND EAST AS THERE WAS NO BETTER EVIDENCE. PROBING AND SEARCHING WITH METAL DETECTOR NOTHING OF INTEREST. SET "SURVEY MARKER" SIGN IN CORNER POST FACING TOWARDS REBAR (WEST) AS WITNESS TO CORNER. COUNTY RECORDS DO NOT SHOW THERE HAVING BEEN SET ANY CORNER HERE. IF FENCE LINE FROM SOUTH PROJECTED NORTH, AERIAL PHOTOS FROM THE 1930'S AND 1940'S SHOWS FENCE OCCUPYING SAME PLACE (AS NEAR AS CAN BE DETERMINED).
