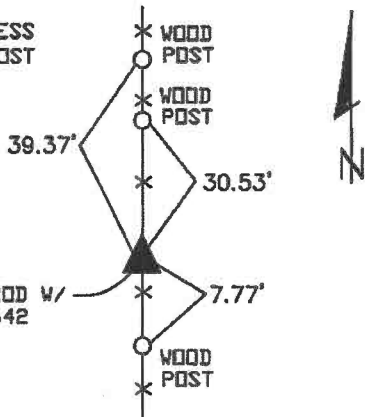

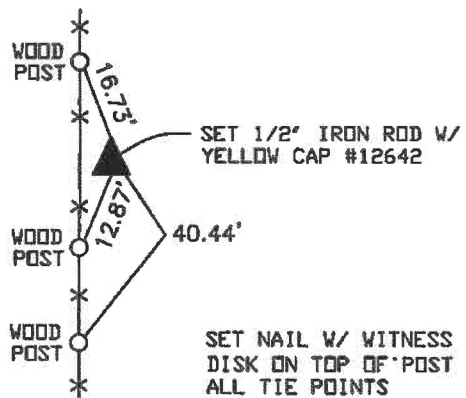

SET NAIL W/ WITNESS DISK ON TOP OF POST ALL TIE POINTS

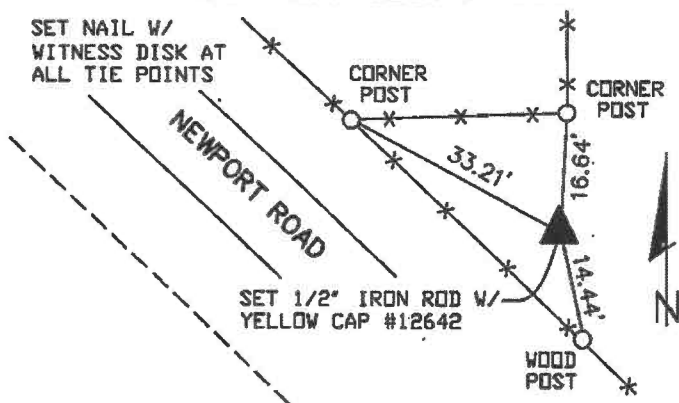

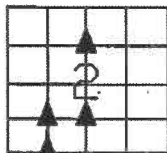
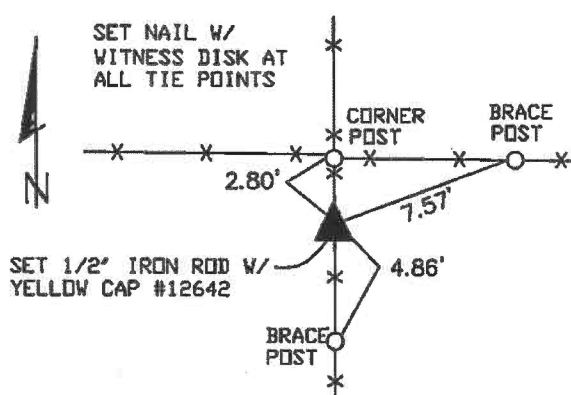
